5:09pm Executive Director's Report and Discussion

No new updates since the April 27 meeting.

Most recent financials (February) are strong: Days of cash on hand at 101 (up from 97 in December). DSCR at 1.36 (up from 1.33 in December). The school is practicing strong cost control.

Current fundraising efforts are as follows:

- \$119,500 raised through grants (\$14,500 from Dell; \$55,000 from Bloomberg Philanthropies; \$50,000 from OSSE)
- \$18,420 raised through private donations

General Academics

- Breakthrough is wrapping up PARCC and DC Science. iReady begins next week.
- We continue to track lessons given to students via Transparent Classroom. We analyze the average number of lessons given to students across classrooms and across disciplines.
- Sara asked about follow up work tracking is it a lack of follow up issue or lack of capture Transparent Classroom is tricky to use

Special Education

Breakthrough has taken the following steps to improve Special Education compliance and programming

- Community Meeting on Special Education Eligibility and IEP process, held in January 2023.
- Community Meeting on Specialized Instruction, Related Services, and Extended School Year, held on May 16.
- Audit of specialized instruction hours; 17 students identified as needing additional specialized instruction. Hours will be provided during the remainder of the school year as well as during summer learning
- Family observations of specialized instruction
- Special Education Coordinator hired through the end of the year
- PWN's (prior written notices) entered for all students who are out of compliance in SEDS
- Revised service hour logs
- Working towards a comprehensive MTSS (Multi-Tiered Support Systems or Child Support Services) for SY23-24
- Beginning to plan for necessary Special Ed professional development for next year
- Vivek asked about documenting guidelines Parents want to know how to track performance against IEP. Related service providers have tracking protocol and system tightly defined by IDEA. Specialized instruction is not explicitly set forth in IDEA so schools have discretion in how they're tracking special education. Purview of Director of Student Support to get involved in those decisions.

Current compliance levels are as follows (decrease is compliance since April; decrease in students with overdue dates):

Facilities

- Still pending construction on new offices
- Still pending review of playground Safety Audit
- Still pending review of Christopher Lalik's school facilities safety audit.
